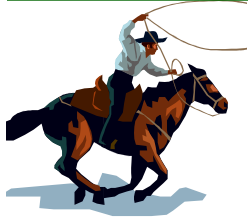

GENERAL MEETING MINUTES

Feb. 11, 2013

President Terry Udell called the meeting to order at 6:45 pm following a pot luck dinner.

Guests present were **Morgan Thompson**, attending with Elvira Pinther, **Kristen Larson**, granddaughter of Ingrid and Rod Larson, and **Dr. Tatiana Steele**, guest speaker, and her husband, **Rick**.

Program: Barbara Guilford introduced Dr. Tatiana Steele as a dear friend to our club. Dr. Steele has been helpful in the past as an interpreter for incoming exchanges, dental hygienist to many of our members and now a dentist providing service to many of our members.

Dr. Steele or “Tania”, as she is known by many, left the former Soviet Republic State of Moldova, roughly 4 million in population, in 1995. She recommended visiting U-Tube to watch short videos of Kishinev, the capital off Moldova, a city of a little less than 1 million people and well known for its wines and as one of the greenest cities in Europe with beautiful parks and trees.

Her husband, Rick, created a dash board video of the Cheyenne area which Tatiana thought depicted a dessert like area without trees and was told there were probably more antelope than people. This was very different from the Hollywood look she had seen from movies...and....then there was the wind!

Returning from a happy month long visit back to Moldova, after living in the U. S. for about 1 ½ years, Tatiana realized that Wyoming was really home even though she missed Moldova. Eventually, her parents were able to relocate to Cheyenne and have enjoyed living so close to their four granddaughters. Although the retirement age is lower in Russia, bringing her parents to Wyoming has more than likely extended their lives especially for her father through healthy activity not typical in Russia for older men.

Tatiana was not able to practice dentistry in the U.S. without going through more years of education in the states and since she had become an instant mother to Rick’s young daughters, the Dental Hygiene program at L.C.C.C. seemed like a good fit. In Russia, the government provides the education, a place to work and the paycheck so Tatiana learned how to be a “good” boss by observing her various employers while working as a hygienist. Eventually with the prodding from a friend in Denver and jumping many hurdles, Tatiana passed her dental boards and other various tests after successfully finishing a 2 year fast track dental program in Denver, CO.

Wyoming is “home” for Dr. Steele, her husband, Rick, their 4 daughters, her parents and the family dog. Dr. Steele’s dental practice is just around the corner from our meeting place on 19th St., close to Cheyenne’s historical downtown she has come to love.

Dr. Steele’s advice is to always show up for your dental appointments because when you don’t it affects the dentist’s overhead and prices will go up!

New Business: Membership Chairman, Donna Logan, stated that we have 50 paid members and of the 14 that haven’t paid, 4 will not be rejoining and 4 have not responded to messages. Donna passed out membership cards with an information sheet that is to be checked for any errors and returned ASAP. Donna will use this information to recognize birthdays and anniversaries at each monthly meeting. Please contact Donna about any illness status so that she can send cards.

- Mr. and Mrs. Ed Warsaw sent in payment for their memberships with a request for a paper version of the newsletter for Sylvia to stay in “touch “with the club. Ed reports that Sylvia’s inputs are fine; it’s only the outputs that are broken. She loves to “touch” with her left hand. Sylvia enjoys visitors between 11-noon and 4-6 pm.
- Tim Bolin stated the dates for the out-going exchange are May 15-22nd this year. Tim will serve as the E.D. and a volunteer is needed to be the treasurer. He reported that Denver cheap flights could be found as low as \$240 but best seating flights were around \$662 round trip. Be sure to ask about additional fees especially for baggage. Limited seats were available flying out of Cheyenne. April 1, 2013 is the exchange deadline with 14 reserved spots and room for possibly 6 more to attend.
- Our requests for exchanges outside the U.S. have been limited. 1/3 of Friendship Force clubs are located in the U.S. Overseas clubs have had such high demands for visits to their locations that they have been overburdened. Our Mexico and Canada requests were denied but we are approved to put a request in for Australia & New Zealand before March 31st.
- At the Feb. board meeting a request was made to check on our tax status. At present, we are NOT registered as a nonprofit organization with the State of Wyoming.
- FFI states that each club is an individual and is not under their “umbrella” of coverage. Clubs are to follow the laws of their country and to have a set of by-laws and state?

 - 1) Do we register with the state? and 2) Do we organize as a corporation?
- There is a \$400 yearly fee to register with the IRS and Mr. Eddie Bridgeman(a member of FF) provides a service of preparing IRS form 1023 for a fee of \$125.00.
- FFI American clubs are fortunate in that they are covered with up to 1 million dollars of liability through FFI. Certificates of insurance can be provided for U.S. events by contacting FFI.
- Carolyn Webber made a motion to register with the Secretary of the State of WY. Rod Larson made a second.
- Donna Logan made a motion to NOT file with the IRS. Eleanor Hanson made a second.
- Loretta Humphrey volunteered to fill out the necessary tax forms.
- Barbara Guilford announced that this was the Chinese New Year, the year of the snake, and that we all need to clean house in preparation!
- Howard Last audited the treasurer's accounts for the year 2012 and found them to be in order. He commends the Treasurer for doing an excellent job.
- Howard Last suggests that the audit be performed at the end of the Treasurer's term of office making a nice transition for the incoming officer and conform to the calendar year.
- Bob and Judy Eatmon's daughter, Jennifer, recently delivered a baby that required a life-flight to Denver. Please keep them in your thoughts and prayers.
- Meeting adjourned at 7:55pm.
